- 6. You must not use these premises for any commercial purposes.
- 7. You must report any incident to the Concierge/Building Manager as soon as reasonably practicable.
- 8. You and your guests must comply with any request from the Owners Corporation's representatives to immediately leave the wharf due to reckless or unreasonable behaviour.
- 9. No refuse shall be thrown overboard or left on the pontoons, jetties, or car parks or disposed of in any way other than in the provided receptacles or by removal.
- 10. No oil or noxious substances including discharge from vessels' heads and/or holding tanks shall be discharged from vessels whilst moored in the Wharf.
- 11. No items of boat gear, fittings, equipment, supplies, stores, tools, materials, or rubbish shall be left on the pontoons, jetties, or car parks.
- 12. The Owners Corporation reserves the right to introduce regulations which relate to the Wharf and premises, and which are not inconsistent with these Conditions and to amend such regulations from time to time.
- 13. Vessels berthed may not be used as static houseboats or for permanent residential purposes and must be kept in a mobile and seaworthy condition.
- 14. You shall at all times be responsible for the proper upkeep and safe condition of the vessel, its gear, and equipment and maintain it in good clean, and seaworthy condition, and ensure the vessel is able to navigate under its own power at all times.
- 15. Only minor maintenance or non-waste generating works are to be carried out whilst the vessel is located in a berth.
- 16. If a contractor requires access to conduct work on a vessel, they must have an access device fob to gain entry to the Marina. If an access device has not been provided by the owner, the contractor must sign in at the Concierge desk.
- 17. Repairs and maintenance are not to be carried out on the Wharf walkways.
- 18. Swimming, diving, or fishing within the Wharf is prohibited.
